### 76th.AIPS Congress Decleration

" AIPS Europe views with extreme concern to the fact that more and more often, European journalists face demands for accreditation fees both national and news access to for international sports events within Europe. These financial demands emanate from commercial agencies, professional leagues and sports federations. This discriminates between organizations which can afford to pay such fees and those which cannot. This risks distotring journalistic independence. AIPS Europe requests that the European Parliament examines this issue which contravenes the Convention of Human Rights".

### 07.10.2014



Petition 0745/2013 by the European Sports Press Association, on the accreditation fees that radio sports journalists are required to pay in Europe.

The petitioner is protesting against the accreditation fees that sports federations and marketing agencies require sports journalists to pay in Europe.

Journalists are obliged to pay accreditation fees to be allowed in to events in order to provide radio coverage. Those fees can be so high as to jeopardise the public's right to information by making it impossible for journalists to perform their professional duties.

The petitioner draws attention in particular to the problems encountered by the French public broadcaster in covering Champions League matches, owing to the excessively high accreditation fees charged (EUR 26 000 for the match between Manchester United and Olympique de Marseille), and to similar problems arising in connection with La Liga matches and the Giro d'Italia.
