Nevertheless, for a more active role within the European Sports Community the EFPM needs to establish an own office run by professional stuff.

This means funding subsidy and financial support.

No way left than to continue the struggle for money, the consultation and discussion with relevant, governmental and non-governmental, partners.

# **EFPM Cooperation**

The long term relationship with International/European organisations have been intensified with common fair play activities set up within championships and by consultations with relevant representatives.

The EFPM has attended several events represented by it's respective members, for example:

The informal partnership between ENGSO and EFPM has finally reached a new quality by signing the MoU in Baku, October 2015.

The cooperation with the EUSA by the presence of EFPM representatives at the General Assembly, different championships, EUSA Games 2016 etc. is taking a successful approach.

At the Gala of the General Assembly in Poland the EUSA awarded Miroslav Cerar, EFPM Vicepresident, with the Order of Merit for his outstanding sportslife and role model.

The EFPM Awarding at the EFC, ETTU, EHF youth championships in the last year became regular and well established highlights.

We are consequently working on raising our relationship to the EOC, participating at their annual GA, continue the consultations with the EC as well as establish contact with several European NOC not being involved or inactive in EFPM.

We also continue our bilateral relation and cooperation with the CIFP, CSIT, AIPS Europe in different cases and play a very active role in the EPAS Consultative Committee.

## **EFPM Affiliation**

We gladly welcome the British Olympic Foundation representing the United Kingdom and Panathlon Wallonie-Bruxelles representing Belgium as new corporate members.

The EFPM tries very hard to reactivate the relations with some "sleeping" members and on the other hand endorse affiliation of new members, especially NOC`s and European Sports Federations as ETU, ETTU, FIBA Europe etc.

The Consultation around the content of the MoU with the Panathlon International is still going on and will probably be finished in the near future.

# **European Fair Play Awards**

At the last GA in Baku the Modifications of the Award Regulations have unanimously been accepted.

Besides, EFPM Awards have been granted at different European Youth Championships.

# **European Fair Play Congresses**

The first Joint EFP/CIFP Congress in Baku, discussing the topic "Fair Play in competitive sports – making it real or just an ideal" has finally been a big success highlighted by the Fair Play Award Gala Ceremony.

The Government of the Republic of Azerbaijan represented by Azad Rahimov, Minister of Youth and Sports, the NOC Azerbaijan, the Fair Play Comission, especially Mr. Khazar Isajew and Mrs. Salhat Abasova, and a common spirit of cooperation led to a big victory.

The evaluation survey, elaborated by Steve Town, clearly shows that the participants welcome some modification of the program:

- -more comfortable time table,
- -taking care of the quality of the keynotes and
- -panel discussion probably at the end of every session.

Finally,the NOC Israel submitted the official application for the organization of the 23<sup>rd</sup> EFP Congress and GA in 2017.

# **Brighton Declaration on Women and Sports**

After the signature of the Declaration EFPM has been invited to the European Women and Sports Conference in Stockholm, April 2016.

Mrs. Kveta Peckova, as EFPM representative, gave a short information/introduction underlining that EFPM will play an active role and completely contribute the aims and goals.
