NATIONAL REPORT 2019

2019 still aims at a new vision of ethical issues and the promotion of sports values within the civil society. After the convocation of the second edition of the States General of Italian Sport, the analyzes carried out in the first, confirm the need to reform the Italian Constitution itself and to propose, for part of the sports associations, a comprehensive and organic reform project of the subject, according to the vision of those who have gained experience and guidance in the field. A serious modification of school programs for the "primaries" with the mandatory introduction of physical-motor education and education based on the principles of fair play. The desired change, which sees Meritorious Associations open up to new synergies, to the philosophy of sharing objectives and operational means, of projects open to collaboration with third parties through a profitable cultural activity. The problems of integration and inclusion resulting from the crisis in the Mediterranean area, in terms of social responsibility, have led us to seriously consider the need to carry out an action that goes beyond normality, which takes on the great need to adapt the our civil society and the necessary process of reconciliation between peoples that have common cultural roots. The first project drawn up for 2019, is in fact the continuation, the second edition of is FAIR PLAY FOR CIVILTY, with a value of at least three years, not ephemeral, but enduring and therefore performing as OIKOUMENE MEDITERRANEAN FAIR PLAY RECONCILIATION, according to project. Both projects incorporate the experiences and resources generated by the previous ones, such as "COMMUNICATING SPORT / SPORT MEMORY", "ETHICS AND VALUES OF SPORT", "SOCIALMEDITERSPORT" and "SCHOOL OF FAIR PLAY". It is indeed the first of the four projects presented at CONI in 2017 and which in any case constitutes the backbone of the commitment planned for 2019.



"FAIR PLAY FOR CIVILITY" is a project, a backbone that aims to help adolescents, from eight to fifteen / seventeen, through sports, to develop their potential, to overcome moments of crisis, school failures and relational, not to take shortcuts and above all, given the rapid changes in society, to prepare them for the future; to make them become courageous, loyal men, ready to take on responsibilities and commitments in the direction of the "common good" and "civil values". "If I listen, I forget, if I see I remember, if I do I learn." The old Chinese proverb could well summarize the pedagogical, didactic and experimental method that we would like to adopt in the management of this initiative that we consider to be "human ecology". The project is certainly challenging. The idea was born because a widespread demand, found in professional activity, both sporting and psychological, is that of many parents who ask for help for the "management" of their children, "difficult" adolescents. There are so many mothers and many frightened fathers, disoriented by a society in rapid change, who do not find the suitable means to help them, decidedly incapable of relating to them. We know that the job of parents teaches no one and, when a serious problem arises, it is either too late, or there are no adequate facilities to treat it. Hence the idea of combining an emotional and attractive outdoor activity with personal and collective responsibility: Help for parents, help for children. The project should last three / five years, should involve at least one city for each of the twenty Italian regions per year. At the end of the five years we expect to have touched and stopped in all the provincial cities of Italy.



MEDITERRANEAN FAIR PLAY RECONCILIATION Getting out of the self-referentiality of the sports movement, transferring values and methods, using the consolidated prestige of the existing network made up of organizations, activities, men and women athletes, managers, organizers, journalists, means opening up to the idea of a recovered "Oikoumene "Operators of the connected realities, of culture, art, knowledge, work and education, of science, fundamental articulations of civil society, which must not necessarily be seen and seasoned as entities belonging to countries divided by



geopolitical boundaries, but as a unicum, a community eager to improve its statius through virtuous cooperation, through the principles of fair play and the deep and inalienial roots of belonging to the international sports community.

So let's go back to the general planning of the CNIFP activity for 2019, in the continuation of the collaboration with the ISCA (International Sport and Culture Association) for the promotion of "Moving People", a European project projected towards 2020, with the intent to involve in physical activity a further one hundred million people, with particular reference to urban areas. The collaboration relationship with the ANCI continues and therefore for 2019 oriented on projects of activities on the territory and initiatives aimed at a strong interaction with the world of education and social work. For this reason, in 2019, the research and selection of FAIR PLAY COMPANY. Foundations as Third Pillar - Mediterranean Italy and Organizations specialized in territorial optimization, rather than with Municipalities such as Alghero, Ponzano Veneto, Amelia or Isernia or Cortina itself with the first edition of AGATA ALLEGRA DISCOVERING THE CRYSTAL, dedicated to the skiing activity of disabled children, all strategic avenues for achieving the associative goals, which see the new Metropolitan Areas as possibilities of a geometric development of collaboration. A new, very last contact is with the Metropolitan Area of Bologna, also with a particular attention to the promotion of the powers of fair play in all the Municipalities.
