## 1. Welcome speech by the President

The EFPM President Philippe Housiaux, welcomed the members and announced the start up of the 30th EFPM Anniversary celebrations.

# 2. Presentation of the participating EFPM Members and confirmation of the necessary Quorum

The quorum (40% of the 29 Members that have settled their financial obligations up to the 27th of May 2024, i.e. 12 Members present) was confirmed with eighteen (18) EFPM Corporate Members present, six (6) Associated Members and three (3) Honorary Members. Consequently, the General Assembly was opened, in accordance with the requirements of the Statutes.

## 3. Approval of the Agenda

The Gen. Assembly Members approved unanimously the proposed Agenda of the 29th EFPM Gen. Asembly

#### 4. Gen. Secretary's guidelines for the Gen. Assembly procedure

The Gen. Secretary I. Psilopoulos explained to the participants how the on-line Gen. Assembly will run, i.e how the participants will intervene in the discussions, how they will vote etc.

#### 5. Welcome speeches by the Guests

The President congratulated the EFPM founding Members present at the session, namely Mr. Erdogan Aripinar, Prof. Dr. Manfred Laemmer and Mr. Christian Hinterberger, who are also Honorary EFPM Members, and gave the floor to them for addressing the Gen. Assembly.

#### 6. Approval of the 2023 Gen. Assembly Minutes

The General Assembly Members approved unanimously the 2023 Gen. Assembly Minutes.

#### 7. President's Report

The President Mr. Housiaux reported to the G.A. about how the work within the EFPM and the member organizations had progressed since the 2023 On-line General Assembly, with focusing on the EFPM Strategy, the World Fair Play Day and the rest projects that were attended by the EFPM, the Financial Management and the future Projects.

# 12. Approval of the 2023 Provisional Budget

The Treasurer Katarina Raczova presented the 2024 provisional Budget, underlining that it is a conservative one not without ambitions, but which will be realised only if we will have the appropriate Income. The Gen. Assembly approved the proposed Budget.

## 13. EFPM 2024 and 2025 Prospective Program

The President presented several tools for the celebration of the EFPM 30th Anniversary:

- **Anniversary Logo**: The President presented the logo that will be used during the celebration period.
- **Crossing Europe for Fair Play and Peace** : Kasparas Sileikis, Member of the Working Group for the celebration of the 30th Anniversary, presented the initiative and called the EFPM Members to fully support it.
- **Fair Play Awards :** Katarina Raczova, responsible for the action, explained the relevant procedures for the coming years.

• **Anniversary Clip:** Charles Camenzuli, President of Aips Europe explained the initiative, which will be realised by his staff, with the assistance of the Gen. Secretary I. Psilopoulos, who will provide the necessary material from the EFPM Archives.

The President continues his presentation of the 2024-2025 prospective activities, as follows:

- Ischia Event: The local commission which organises an annual event of significant importance, decided to cooperate with the Italian Fair Play Committee and include the 30th Anniversary of the CIFP celebration in this event. In conjunction with this, the Organising Committee invited the EFPM to take part in said celebration, taking the opportunity to introduce the EFPM 30th Anniversary and some relevant activities (speeches, awards etc.). The EFPM Ex. Committee accepted the invitation and will take part in this event on the 2 -5 of September 2024.
- **2024 World Fair Play Day:** It will be organised in Brussels on the 5th of September 2024 and the central issue will be the "Annual Fair Play for Peace Award". This prize will be attributed to the United Nations High Commissioner for Refugees, Mr. Filipo Grandi.
- **2024 EFPM Congress:** It will take place on the 17 18 December 2024 at the University of Louvain-La-Neuve, in Belgium. The head of the EFPM Scientific Advisors Committee Thierry Zintz, has prepared the Program of the relevant activities as well as the ensuring of the accommodation and food facilities. The relevant program was presented to the Gen. Assembly.
- **2024 Fair Play Event in Mardin, Turkey:** Our Turkish partner, the Turkish Fair Play Committee is willing together with the city of Mardin to organise a EFPM event at the occasion of the EFPM 30th Anniversary. The case will be duly examined
- **2025 EFPM Congress and Electoral Gen. Assembly:** The Gen. Secretary I. Psilopoulos presented the proposal of the Hellenic Olympic Academy to host the Event at the premises of the International Olympic Academy in Ancient Olympia, Greece, in May 2025. With this event we shall close the 30th Anniversary of the EFPM in a symbolic way, in the cradle of Olympism.

The General Assembly Members approved unanimously the 2024 - 2025 prospective Program.

## 14. Miscellaneous

The representatives of CIFP, ENGSO an EUSA thanked the EFPM for the invitation to the present General Assembly and wishhed the best for the development of the EFPM in the yearts to come.

The President Ph. Housiaux thanked the participants for their cooperation and declared the session closed.
