### 1. Welcome speech by the President

The EFPM President Philippe Housiaux, welcomed the members and the EFPM Gen. Secretary I. Psilopoulos read the message of the EOC President Mr. Kapralos

#### 2. Presentation of the participating EFPM Members and confirmation of the necessary Quorum

The quorum (40% of the 29 Members that have settled their financial obligations up to the 27th of May 2024, i.e. 12 Members present) was confirmed with twenty-two (22) EFPM Corporate Members present, six (6) Associated Members and one (1) Honorary Member. Consequently, the General Assembly was opened, in accordance with the requirements of the Statutes.

# 5. President's Report

The President Mr. Housiaux reported to the G.A. about how the work within the EFPM and the member organizations had progressed since the 2024 On-line General Assembly, with focusing on the EFPM Strategy, the World Fair Play Day, the EFPM-EU relations and the RELAY FOR PEACE AND FAIR PLAY project, the Financial Management and the future Projects.

Especially for the last issues President Housiaux asked the persons that dealt with these projects to introduce the cases.

**5.1.** The EFPM Advisor Kole Gjeloshaj introduced the 2021-2024 EFPM – European Commission relations as follows:

#### a. EU administrative registration:

- **EU Funding & Tenders Portal**: EFPM is now registered and has a PIC number (February 2025). It means EFPM may apply to EU projects.
- **EU Transparency platform**: it means that EFPM may have meetings with EU Commission or Parliament members (elected, nominated or hired) and has the right to access to the official EU buildings. To communicate with the EU authorities the specific registration number must be used. It is a different one than the one of the EU Funding & tenders' portal.

d.3. SAFE – Safeguarding Approaches Focusing on grassroots sport Elements:

Main topic of the project: Safeguarding in sport

**Background:** In the latest period IOC released a brand-new protocol for safeguarding in sport. Although the protocol is well structured and very comprehensive is designed to target elite sport. This leaves a big gap for grassroots sport realities that need to adopt a safeguarding procedure in their club but do not have big resources to adopt such a complex protocol and risk to keep their environment under the risk of unsafe practices.

**Aim:** Ultimately, the project will raise the capacity of sport organisations at grassroots level to implement an effective safeguarding protocol in their daily work aligning with man references for safeguarding at international level.

**5.2.** The EFPM Coordinator of the RELAY FOR PEACE AND FAIR PLAY Project Kasparas Sileikis introduced his relevant report accompanied by an associated video as follows:

2024 marked the 30th anniversary of the European Fair Play Movement. To celebrate this anniversary the EFPM launched the initiative "Crossing Europe for Fair Play and Peace", a virtual relay uniting athletes, students, educators, and sports lovers across Europe.

For this project, each participating country had to cover the virtual distance from their capital city to Brussels. The activities included: running, walking, cycling, swimming, hiking, rowing and playing sports and were coordinated nationally but united globally in one shared goal: to promote Fair Play and Peace. The following countries participated in the Project: Azerbaijan, Belgium, Greece, Italy, Latvia, Portugal, San Marino, Slovakia and Spain.

The Olympic torch relay begins in Olympia, our relay for Fair Play and Peace ends here... for now...

The representatives of ENGSO an EUSA thanked the EFPM for the invitation to the present General

Assembly and wished the best for the development of the EFPM in the years to come.

Ms. Marlyse Royer, Representing the "Stop Racism in Sport" Organisation applied for the affiliation

of said Organisation as Associated Member of the EFPM. The General Assembly unanimously

approved the application and welcomed them to the EFPM family.

Having dealt with all the points of the Agenda, the President thanked the EFPM members for their

support and declared the General Assembly closed.

12. Elections

The General Secretary Ioannis Psilopoulos presented the elections procedure to the participants.

The General Assembly approved the proposal of the EFPM Ex. Committee and elected as scrutineers
