The main aim of the EFPM is to promote Fair Play and Tolerance in the broadest sense (in sports and everyday life) at European level. The EFPM seeks to achieve this goal by supporting its members, by helping to promote Fair Play campaigns where sports organisations take the initiative, by co-operating with the authorities to foster Fair Play themes and by facilitating regular contacts between the various European sports organisations.

The goal of EFPM Flash News is to inform about EFPM activities and to establish a closer contact not only with all the EFPM members but also with all European governmental and non-governmental sport institutions and organisations, aiming to support and to contribute to the promotion of Ethics in Sport and to the spreading of the Fair Play values and principles in all sporting activities as well as in daily life

Moreover, during the meeting President Erdener declared that Istanbul will be candidate for the EFP Congress in 2013.

Olympic Committee (CONI), its Fair Play Committee under the leadership of Ruggero Alcanterini and supported by the municipality of Verona. As announced in previous communications the date of this event is October 25 - 27, 2012. A visit to the Congress and General Assembly venues is scheduled. Executive Committee Members will decide about the endorsement of the organisation of the XIX. European Fair Play Congress in 2013 and the XIX. EFPM General Assembly.

and national Fair Play Organizations, announces Fair Play Awards at important European youth events. As a result, activities aimed at strengthening the ethical dimension of sport were integrated into the competitions. It is always a pleasure and honour to decorate young athletes for their behaviour supporting and following the essence of Fair Play. We would like to ask the national Fair Play organizations, Sport Federations to keep us informed about the various important youth sports events so we can create more visibility for the Fair Play awards. And we hope to report about even more Fair Play acts and fair, tolerant behaviour in the future!

The Italian Fair Play Committee (CNIFP), in collaboration with the Regional Committee of Campania, organized a gala dedicated to Fair Play in the medieval Castel Nuovo of Naples. The meeting was attended by the Mayor of Naples, Luigi De Magistris, the Councillor for Equal Opportunities and Youth Policy and Sports Pina Tommasielli, the President of the

Italian National Committee for Fair Play, Ruggero Alcanterini, and many personalities from the world of sports, culture, politics and representatives of mass media. Sarah Izzo, the first Italian Miss Fair Play, a 20 years old student in Medicine, was also among the invited guests.

Aim of the Fair Play gala was to strengthen the cooperation between the city of Naples and the CNIFP to underline the validity of the project "Ethics Alliance and National Territorial Diffusion". The project promises to become a fruitful collaboration. It launches important messages politicians to emphasize the big challenge of the right to practise sports in a safe environment and the right to protect health and culture. The alliance with the CNIFP is aimed at activities to improve the social environment and also at

concrete projects related to the revival of socio-cultural tourism in Naples. Last but not least, it also aims at making the European Fair Play movement



more popular and promotes the XVIII European Fair Play Congress taking place in Verona in October 2012.

Herebelow, we would like to share some positive examples of fair behaviour, that will hopefully inspire athletes, trainers and fans around the world.

During the men's alpine skiing World Cup slalom race in Wengen (SUI), on January 15, the Canadian Olympic and World Cup skier Brad Spence showcased an exemplary behaviour: He wore a helmet with a special logo bearing the name of Gage Ferguson, an eight-year-old from Calgary, who suffers from Asperger Syndrome. After seeing Brad's call for a new sponsor, Gage offered to be Spence's personal sponsor and support his hero's career - donating money from his piggy bank. "I was quite taken aback Gage wanted to spend his piggy-bank savings to help me follow my dreams. In a world where generous people often

aren't rewarded to the extent they deserve, I wanted to do my best to return the favour", the 27-year-old Spence said. So in return, one of the sponsors of Canada's Alpine team invited the 8-year-old and his mother to an all-inclusive stay at the race in Wengen. Gage even had access to the area usually reserved only to athletes and their trainers. The money Gage saved in his piggy bank — a total of \$149, 39 — will be donated to the Branch Out Foundation for research into therapy for neurological disorders to find a cure for the various complications of the nervous system.

The Italian second division defender Simone Farina has been showcased as an example by FIFA after refusing a 200,000-euro offer to fix an Italian Cup match between Cesena and his club Gubbio in November.

"He displayed model behaviour for young players; he resisted significant money to fix what many players would consider an unimportant fixture. He resisted and rejected a corrupting offer but, more importantly, he reported it," FIFA Head of Security

Chris Eaton said, praising Simone Farina. The player was appointed a FIFA Fair Play Ambassador by its president Sepp Blatter and received a special FIFA Award at this year's FIFA Wolrd's Player of the Year ceremony. There is no doubt about the growing concern of people trying to manipulate games. Therefore it is highly significant to emphasize Simone's act, who didn't just show courage identifying this problem but refused to give in.

Yes, football gentlemen still do exist. The most recent proof for Fair Play comes from the Czech

Republic. His team was losing 0:1 against Meteor Praha, when the player Petr Mikolanda refused the opportunity to equalize the score thanks to a

penalty. Why? The 27-year-old admitted that he had touched the ball with his hands and not his opponent, so there was no reason for a penalty. His team ended up losing 1:3 but Mikolanda was satisfied with his decision. He said: "I knew that I

had touched the ball with my hand, so I was very surprised when the referee decided for a penalty. I didn't hesitate a second to admit my fault. I did the right thing. I'm not a pig that needs to cheat to score."

The International Ski Federation (FIS) has launched 'Clean as Snow' at its Nordic World Cup event in Finland and joins the list of WADA stakeholders to adopt the anti-doping awareness model 'Say NO! To Doping'. FIS is the 14th International Federation to incorporate 'Say NO! To Doping' into its overall anti-doping program and aims to spread the message to all skiers and snowboarders over the forthcoming winter season. "Clean as Snow" was launched with the support of the FIS Athletes' Commission, and

athletes at the FIS event in Ruka have been asked to show their support by sharing anti-doping leaflets and signing a special branded glass In the finish area. "W athletes are role models for thousands of young sports-motivated people," explained Kikkan Randall, the FIS Athletes' Commission representative for ladies' cross-country skiing. "We have to give best examples. Teach them the value of a clean sports performance for their future career and future health. That is my message."
