Olympic Committee of Slovenia led in 2020 a national program for promoting sporting behavior, Olympic values, Fair Play and protection of athletes and coaches against manipulations and abuses. Activities of the program have been supported by the Ministry of Education, Science and Sport and also by the IOC Olympic Solidarity.

As part of the program, we can highlight workshops for young and elite athletes (candidates for Tokyo 2020 Olympic Games, participants to the YOG Lausanne, members of national teams in different sports), operation of our own Whistle-blower portal Zvizgavka for anonymous reporting on irregularities in sport, participation to sport events, participation to events for awarding athletes on national and local level, awarding athletes, coaches and sport official with national Fair Play awards, nomination of athletes for EFMP and CIFP awards, work of independent Ethic Commission, implementation of Fair Play protocol at sport for all programs and events (School sport games, Mini Olympics, Olympic camp, Olympic festival, Olympic hours for children), supporting coordination of National platform for protecting sport from manipulations, supporting humanity, integrity and transparency in sport.

The activities carried out followed our annual plan, confirmed by the General Assembly of the Olympic Committee of Slovenia. Due to the declared pandemic and many restrictive measures, attendance at events was lower as some events were not organized.

Among international level activities we can highlight cooperation with the European Fair Play Movement (EFPM) and the International Fair Play Committee (CIFP) and other international organizations and institutions with similar aims and goals for promotion of values in sport. Important part was also participation of Ambassador and his deputies to some international sport events like participation of Miroslav Cerar in an international event before the start of the Biathlon World Cup - Anterselva and awarding a Fair Play award to Johannes Thingnes Bo; EFPM award ceremony to Alex Cisar at the Biathlon World Cup, Pokljuka 2020; participation of



Petra Majdič to the meeting of team leaders and journalists before the Biathlon World Cup in Pokljuka. Ambassador participated also to special events in September 2020 in Ljubljana, when IOC President Thomas Bach and EOC Acting President Mr. Niels Nygaard visited us.

We need to stress that important part of the program of the Olympic Committee of Slovenia for promotion of Olympic values, Fair Play, protection of athletes and coaches against manipulations and abuses has been implemented by the Ambassador of Fair play, Tolerance and Sport in the Republic of Slovenia Mr. Miroslav Cerar and his deputies, Mrs. Petra Majdič and Dr. Stanislav Pinter.

In October 2020, the Government of the Republic of Slovenia nominated new Ambassador of Fair Play, Tolerance and Sport, Olympian Peter Prevc. For his deputies, Paralympian Franc Pinter and Olympian Maruša Štangar were nominated.
